This act (with/without/or its amendments) is sometimes referred to as the COLOUR BAR or the COLOUR BAR ACT. The term color bar, however, usually refers to a group of labor practices, informal trade union practices, government regulations, and legislation, all of which **were developed over time to prevent blacks from competing for certain categories of jobs monopolized by whites.**
